#### **Appeals**

Athletes who have not been nominated and who wish to appeal this decision can do so by filing an appeal in writing only with the Quest for Gold Ontario Athlete Assistance Program Appeals Committee.

Grounds for appeals will be limited strictly to issues related to:

- Whether or not the Ontario Table Tennis Association completed the selection process in accordance with their own published selection criteria and related procedures.
- Whether or not the selection criteria developed and applied by the Ontario Table Tennis Association were fair, objective, transparent and free from discrimination or conflict of interest.

If it is determined by the Appeals Committee that the Ontario Table Tennis Association did not apply its criteria/ procedures/ process correctly in the selection of athletes the Ministry will direct the Ontario Table Tennis Association to redo the selection process using the correct criteria/process.

The deadline for athletes to submit appeals to the Appeals Committee is **Feb 6, 2007**.
