EVENT DESCRIPTION

MEN'S AND WOMEN'S SINGLES – Saturday morning (9h00) an open qualification tournament will start for men and women separately to determine qualifiers (minimum 5 men and 5 women) to compete against the team players of the National Table Tennis League. The Men's and Women's Singles are Open events. All players may register – up to a maximum of 72 men and 72 women will be accepted (first 72 entered).

JUNIOR BOYS AND JUNIOR GIRLS SINGLES – starts on Saturday afternoon (13h00); RR and Knock-out. All players must be born in 1990 or later.

PARALYMPIC MIXED OPEN SINGLES - starts on Sunday morning; RR and Knock-out.
** Event subject to number of entries.

SPIN ATTACK DOUBLES – will be held on Sunday; Knock-out. **Please note that the draw for this event will be made on Saturday evening. Due to time scheduling, the Top 8 finishers in the Singles and Junior Singles event will not be able to compete in Doubles.
